



# Associated Student Government (ASG) Application Form 2020-2021

**One (1) Council Member seats are open starting Fall, 2020 term.**

We invite you to apply for a position as Council Member for the OCCC Associated Student Government. ASG works within the guidelines of an established constitution and by-laws as well as Oregon Community Colleges Student Association certification themes: Leadership development, intellectual growth, social responsibility, cultural competency, and effective communication.

## **Description:**

-A councilmember is a voting member of ASG. There are no elected positions, and all members have an equal vote and level of responsibility in their duties and representation. Positions are appointed and selected through the application process.

-As a councilmember you would help facilitate events that enrich or improve student life, including student clubs. Past events have included hosting blood drives, Celebrate Diversity, the food basket, etc.

-As a councilmember you must attend the weekly meetings, and staff the ASG office for at least two hours a week. Lead and/or participate in a minimum of one activity per term.

-The term of a councilmember lasts three academic terms, starting in the fall and ending in the spring. Applicants must make a commitment for all three terms. ASG Council members can be re-appointed for a second year.

## **Qualifications:**

-Be enrolled at OCCC in a minimum of 6 credits per term. Attend OCCC for Fall, Winter, and Spring terms.

-Have and maintain a minimum Grade Point Average (GPA) of 2.5.

## **Specific Duties and Time-line:**

-Commit to attending a Leadership Training Program (time and date to be announced) during the Summer/Fall of 2020 and following workshops throughout the year.

## **Benefits:**

-Receive a tuition waiver for four credits each term.

-Opportunity to develop leadership skills.

-Have a voice in college planning and events.
