## 1. President's update - presented by Greg Dewar

- a. The 21-22 budget is going to the budget committee next Wednesday. The committee is 7 Lincoln County citizens and the 7 elected members of the Board. The committee has the option to approve at the first meeting, or hold a second meeting. The budget then goes to the elected Board, whose responsibility is to adopt the budget. The proposed budget includes a tuition freeze for 21-22. The budget also relies a great deal upon the one-time federal stimulus funding to balance. Otherwise, the combination of dropping enrollment (and tuition revenue) and no tuition increase would require significant reductions in order to reach the legally required balanced budget.
- b. The Legislative session is in its final weeks, and we should soon know where the Community College Support Fund will land. Also a legislative matter is capital construction. OCCC's next building, the Workforce Education Resiliency Center is up for reauthorization. Advocacy for both of these matters has taken some of my time in recent weeks. Testimony remains virtual this year.
- c. Please join us June 11 for Carmencement and Nurse Pinning (mostly virtual, some on-site) and for Celebrate Us, in-person in Newport on June 10.
