

Committee Recommendation for Revised Zone Boundaries Oregon Coast Community College

August 10, 2022

Committee Recommendation to Balance Zones based on 2021 Census
Committee Members: Chandler, Nelson-Robertson, and Osterlund

Background:

ORS 341.327 Method of electing Community College board members.

(a) Elected by electors of zones *as nearly equal in population as possible according to the latest federal census.*

The OCCC District elects board members by seven zones. OCCC zones were determined in 1987 and made up of the 75 Lincoln County precincts which existed in 1987. Lincoln County later combined precincts to a current total of 32. The 32 precinct structure resulted in OCCC having precincts split across zones causing logistical challenges for subsequent elections. The 2020 census revealed population shifts in Lincoln County which created an opportunity to initiate an effort to better balance population within seven zones *“as nearly equal in population as possible according to the latest federal census.”*

The OCCC Board of education appointed a committee to develop a recommendation to adjust the boundaries of current zones to consider shifts in population and, at the request of the Lincoln County Clerk’s office, also ensure that zones no longer split precincts. President Ryslinge served as staff to the committee and provided the 2021 Oregon Secretary of State [Directive on Redistricting](#), 2020 census data, current precincts, maps and County Clerk analysis to committee members for individual review. The committee then met on 06/28/2022 and reached consensus on a recommendation to the OCCC Board to revise the Zone boundaries (see below). Once this process is completed the board must adopt a new district zone map with the adjusted boundaries between zones. Once revised zone boundaries are adopted, College staff will seek to obtain a current OCCC Zone Map to provide a more useful graphical image.

OCCA Counsel, Karen Smith, provides guidance re impact on current elected board members: *When there is a change in zone boundaries, currently elected board members continue to serve the remainder of their terms in the zone to which they are elected. There is no requirement for a new election. When the board member’s term expires, the next elected member (whether it is the current board member running for re-election or a new person) are elected to the updated zone. Given the late release of (2020) census data and filing deadlines, there is no way districts will have the process completed before the May 2021 election so the first time newly zoned seats will be filled will be May 2023.*

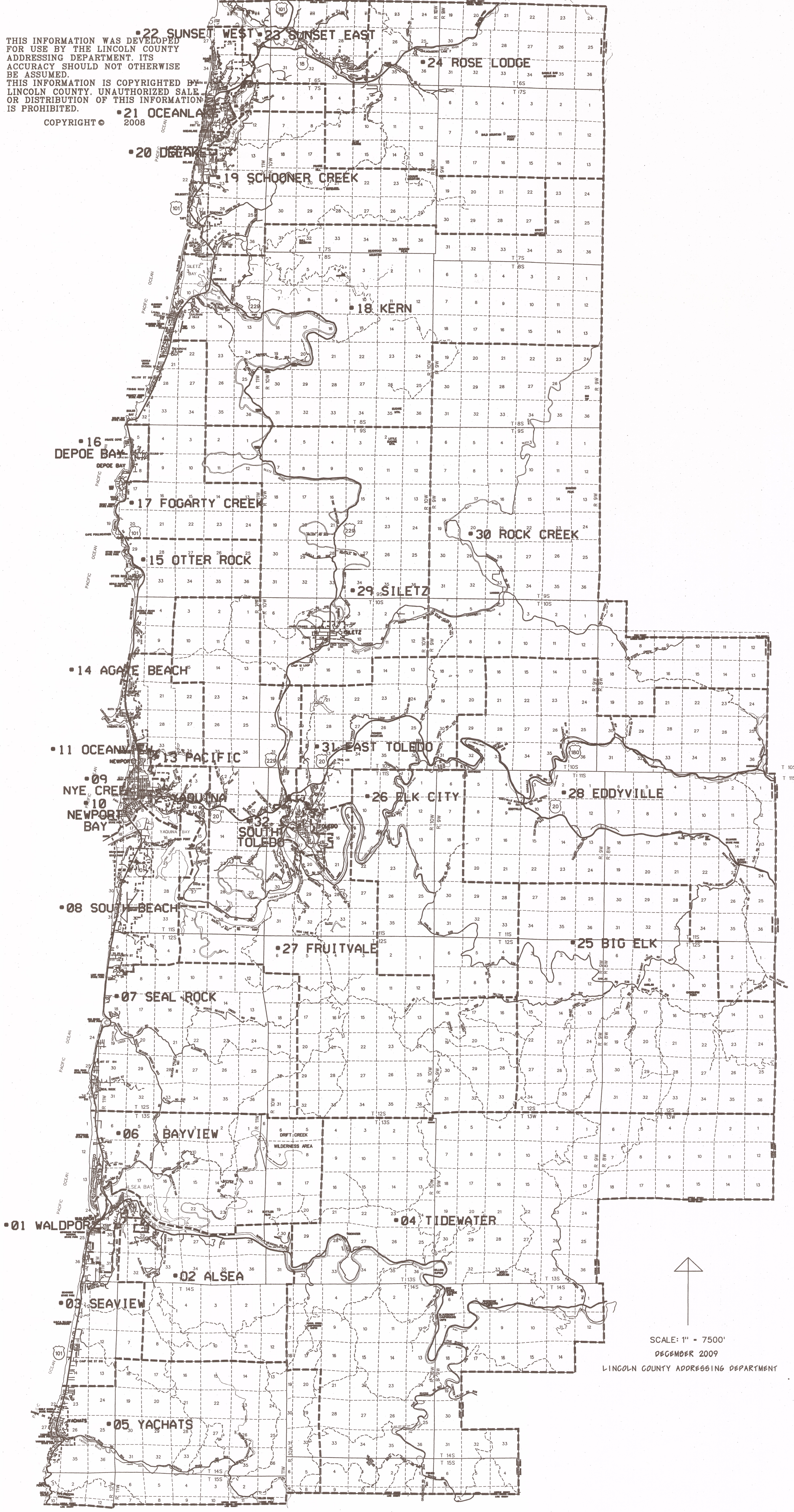
