The Jeanne Clery Disclosure of Campus SecurityPolicy and Campus Crime Statistics Act

The Clery act requires higher ed institutions to disclose information about crimes committed on campuses so students, family and employees can make informed decisions and feel safe

How does it affect us



Institutions who have signed a Program
 Participation Agreement and administer
 financial assistance programs are required to:

Disclose

 statistics of the number of dating violence, domestic violence, sexual assault and stalking incidents

Implement

 preventative measures and trainings around said crimes

Develop and make Available

an emergency response plan

Designate and train

(annually) CampusSecurity Authorities(CSA)


 The Clery act requires an annual report that encompasses an institutions crime stats, Clery geography, preventative policies and emergency response and evacuation procedures
