- The Oregon AI Conference was attended by President Roache and Business Faculty Dr. Flores, with discussions on AI's potential impact on their programs.
- A Town Hall meeting with U.S. Senator Merkley and U.S. Representative Val Hoyle was successful, with a high turnout.
- Upcoming events include the OCC Legislative Summit, a live Town Hall with Senator Dick Anderson and Rep. David Gomberg, and the Pearls of Wisdom (OCCC Foundation annual gala).

c. Title IX, ADA, Drug & Alcohol

Bruce Clemetsen (VP of Academic and Student Affairs) reported on the importance of Title IX, prohibiting sex-based discrimination in educational programs and activities.

- Types of sexual harassment
- Process for handling Title IX complaints.
- Role of the Title IX Coordinator & importance of annual training on legal requirements.
- Report of one Title IX report and investigation in 2023-24. There were no hearings or appeals.
- Overview of the Americans with Disabilities Act (ADA) and Section 504, prohibiting discrimination based on disability.
- Review of student accessibility services and the grievance process for students.
- Resolution of two ADA violations in 2023-24 through voluntary resolution agreements with the Federal Office of Civil Rights.
- Compliance with federal regulations regarding drug and alcohol policies.
- Report of one alcohol and drug-related incident in 2023-24 with no warnings or referrals issued.
