

# Oregon Coast Community College Bond Projects Construction Manager's Report



Report Date: March 11, 2025

## **GENERAL OVERVIEW**

The Programming phase of design for the OCATT building is nearing completion. The summary report will be issued at the end of March. Then we'll negotiate the final design fee. We expect the Schematic Design phase to begin in April with the sitework design completed this summer and final building design completed in January. Construction is expected to begin this Fall. We'll be attending the Pearls of Wisdom event to participate in sharing the latest information about the OCATT Building design progress.

Design for the summer 2025 maintenance renovations for the three campuses is in the early stages of design and will be completed mid-May. Design is just starting for the priority system replacements (HVAC controls, AQS Building AC, access controls and security) and is scheduled for completion in early July. Design for other facility improvements will begin in July.

Advertisement for CM/GC services was published at the end of February and a preproposal site walk was held today with interested contractors. Six companies participated in the meeting. Proposals are due in late March. The proposal review committee will meet on March 27 to score proposals and interviews will be held the first week of April.

## BUDGET

The current program budget summary is shown on the next page. The detailed budget summary is provided separately with this report. Changes since last month are noted below.

## Current Budgets

This section was updated to match the current committed costs. Projected budgets will be added for individual projects as design estimates are completed.

## Committed Costs

Design fee of \$266,411 total was added for the priority system replacements in the four existing buildings. Schematic Design fee of \$77,776 was added for the Summer 2026 mechanical and electrical improvements. Consultant fee of \$35,470 was added for OCATT initial geotechnical engineering surveys. To date, \$2.5 million has been committed.

### Actual Costs

Design fees are being expended as work progresses for each building.

## **PROJECT-SPECIFIC ACTIVITY**

### CM/GC Selection

The final step of the Bond Program Due Diligence phase is procuring the construction contractor through the RFP process. An RFP was published February 28 and a mandatory pre-proposal walk-through of the projects was March 11. Six firms participated in the meeting and site walks. Proposals are due March 25 and the selection committee will meet March 27 to score proposals and select companies for interviews the first week of April. We anticipate bringing the committee's recommendation for a CM/GC company to the BOE meeting in April.

## OCATT Design

The next Programming design meeting will be held on March 13 to refine the building elements based on Focus Group meetings completed in the last few weeks. The Programming phase of design will conclude with a final Programming review on March 27. Following that, the Schematic design phase will begin in April to develop 50% design documents over several months. A preliminary construction cost estimate will be developed after Schematic design in June.

## Existing Building "Fix-It" Design

"Fix-it" work scheduled for completion this summer includes the following items:

- 1) refinishing exterior brick and siding systems
- 2) resolving water intrusion issues
- 3) repairing damaged interior finishes
- 4) replacing corroded interior fixtures in the Aquarium Sciences building
- 5) replacing the roof on the North Campus building

Design will be completed mid-May and we expect construction to begin in July with completion in September 2025.

## Existing Building MEPLV Design

The pre-bond building assessments identified a number of mechanical, electrical, plumbing and low-voltage (MEPLV) issues in the existing buildings. Design started this week for the priority systems of HVAC controls, AQS building air conditioning, access controls and security. These systems were prioritized because they are currently failing. Priority system design will be completed in early July and we expect construction to be completed this Fall. Design for the other mechanical and electrical system improvements will begin in July with construction scheduled for summer 2026.

## Existing Building Interior Improvements

The final planned element of the Bond Program will be improvements to interior spaces at all campuses. This could include renovations to the Central Commons and the North

Lobby and Commons. We expect to start design for these elements in 2026 after the construction budgets for OCATT and the existing facility repairs are well established. Construction of the interior improvements will likely occur during summer 2027 and would conclude the current scope of the Bond Program.
